INFORMATION ABOUT FEEDBACK SYSTEM

The College was granted autonomy from the academic year 2019-20. As a result, during the academic year 2020-21, First Year and Second Year of all Undergraduate and Postgraduate courses were run under the autonomous framework while the Third year of all Undergraduate courses remained affiliated to Savitribai Phule Pune University. So, the feedback on curriculum taken from students of Third year of all Undergraduate courses relates to the syllabi framed by the University. This feedback was taken using the following link hosted on the website of the college

The feedback on curriculum/syllabi framed under autonomy was taken from students of First Year and Second Year of all Undergraduate and Postgraduate courses by using the ERP 'Mograsis'. All the feedback forms and a survey of student satisfaction were made available on the log in id of each student in the ERP 'Mograsis'.

Feedback from Teachers is taken on curriculum designed under autonomy and on implementation of curriculum and also evaluation.


Each feedback form has been designed using a five-point scale. In case of attributes, the rating is based on 'Excellent', 'Very Good', 'Good', 'Average' and 'Unsatisfactory'. In case of statements, the level of agreement with the statement is considered based on' Strongly Agree', 'Agree', 'Neither Agree nor Disagree' (or Not sure), 'Disagree' and 'Strongly Disagree'. In case of satisfaction, the five options were Very Satisfied, Satisfied, Satisfied only to some extent, Neither Satisfied nor dissatisfied (or Neutral) and Not satisfied.

The feedback is based on 15 parameters, some of the parameters are given belower


A detailed report of all parameters is included in the Feedback Report uploaded on the website.

Although, students' responses for Curriculum design under autonomy, Maximum percentage of respondents have rated 'Good', maximum number of students are 'satisfied' (and around 15% and more are Very Satisfied) about the following four parameters

- a) Inclusion of interdisciplinary courses in the programme
- b) Range of electives/ number of optional subjects offered
- c) Add- on- courses provided by the framework and
- d) Internship/practical training included in the framework



Feedback from Teachers






It is observed from the above chart that the Teachers have agreed to majority of the statements and also for most of the statements, they have strongly agreed.



In this above chart, it is observed that there are zero percentage responses for above statements in the category 'strongly disagree' and very negligible (0.6%) in the category 'disagree'. Also, for the above statements, the percentage responses for 'strongly agree' category has increased.

Feedback on Curriculum design and implementation for the courses of Third year (Under graduate) under affiliation system is as follows



Also, the Alumni of Department of Hindi have appreciated the syllabi and considered it fit for employability of students. A summary of feedback from alumni can be accessed on the folder




Feedback from Employers is taken in two ways

- i) Structured as per the form hosted on website of the college. Although this feedback is about the employee, who is a student of this college, it indicates whether the curriculum is designed in such a manner, that certain skills and values are inculcated in the employee during his/her student life.

Summary of suggestions received from students under affiliation system:

- 1) Internships for Biotechnology students
- 2) Include modern day curriculum and syllabus
- 3) Focus on application of knowledge rather than books
- 4) More field trips and study tours should be arranged
- 5) There should be fine arts department

Action Taken

The issue of feedback from stakeholders, more particularly from the students was discussed in the meetings of the Internal Quality Assurance Cell (IQAC) and accordingly, two members of the IQAC were appointed as Feedback Coordinators, who would monitor collection and analysis of structured feedback received from the stake holders. Apart from structured feedback, feedback in informal manner is received from parents during the parents meet, which is communicated to the respective authorities, as the case may be. Informal feedback is also received from

the employers by the placement cell and the same is communicated to the respective authorities, for further action. Efforts are made, as far as possible to ensure that suggestions of employers about curriculum are taken note of.

Although the suggestions from students mentioned above relate to syllabi under affiliation system, the framework under autonomy has included fieldwork and/or internship for the students of each faculty. Also, latest trends are included in the syllabi of the programmes and a course on Fundamentals of music is offered to students of TY of all faculties.

Study tours couldn't be arranged in 2020-21 due to COVID-19 restrictions

Analysis of Structured Feedback from Students and Teachers is placed before the meetings of the IQAC for consideration. The members of IQAC have appreciated the feedback and it was placed before the Governing Body Meeting.
